## University Library License (SPECIAL) Agreement for Publication Archives Provided by Datapages, Inc., on the Internet November 1, 2016 thru October 31, 2017

This Agreement, entered into as of the date last written below is by and between Datapages, Inc., an [Text deleted] (DATAPAGES) and University of California, San Diego, 9500 Gilman Drive, La Jolla, CA 92093-0175 (UCSD) in regard to UCSD receiving a non-exclusive corporate license for access to archives of AAPG, SEPM, JPG, GCAGS, CSPG and other organizations via the internet (PUBS INTERNET). The two parties agree to the following provisions:

- 1. DATAPAGES will provide UCSD access, by means of the internet, with appropriate security, to PUBS INTERNET upon payment of the FEE each year by UCSD. Most text is presented in HTML or XML and images of selected figures are in GIF or JPEG, with server-based search software. Page images are presented in Adobe Acrobat PDF format. The LICENSE is for a term of 12 months and shall be renewed by DATAPAGES each year upon receipt by DATAPAGES from UCSD of the FEE.
- 2. PUBS INTERNET, as of the date hereof, consists of articles and abstracts from AAPG Bulletin 1917-present, 245+ volumes of AAPG Special Publications, SEPM's Journal of Sedimentary Research (JSR) 1931-present, Journal of Petroleum Geology (JPG) 1978-2004, GCAGS Transactions 1951 to present, Canadian Society of Petroleum Geologists Bulletin (CSPG), 1953 to present, and those of other smaller publishers. DATAPAGES does not represent or warrant that PUBS INTERNET will at any time after the date hereof consist of articles and abstracts of the organizations and publishers listed in the previous sentence and DATAPAGES reserves the right to add content to, delete content from, or otherwise change the content of PUBS INTERNET as DATAPAGES determines in its sole discretion. DATAPAGES will provide periodic updates of the publications from time to time comprising PUBS INTERNET as they may be prepared and made available to DATAPAGES for inclusion in PUBS INTERNET during the term of this LICENSE.
- 3. UCSD agrees, in exchange for PUBS INTERNET, to (a) pay Datapages a once-only license fee of [Text deleted]; and (b) a subscription fee of [Text deleted] per year within 30 days of receipt of a correct and properly prepared invoice, thereby activating PUBS INTERNET. As a condition of this subscription, UCSD agrees to and does abide by all of the terms, conditions, rules, and policies for internet access to PUBS INTERNET as from time to time made effective by DATAPAGES, including without limitation those listed in Paragraph 4 below, and provides timely information when requested as how UCSD may receive notices and other information from DATAPAGES. DATAPAGES reserves the right to change all such terms, conditions, rules, and policies from time to time in the sole discretion of DATAPAGES. UCSD may cancel this subscription at any time.

Search-and-retrieval by any other individual or organizations is strictly forbidden. UCSD shall not allow files of PUBS INTERNET to be copied for other individuals or organizations, nor given to individuals or organizations other than those listed in the second sentence of this paragraph, nor shall such files to be placed on an area of a network server that can be accessed by users outside of the UCSD organization. UCSD library staff may print out and send single copies of articles for interlibrary loan. Secure electronic transmission such as that as used by Ariel or Prospero to fulfill interlibrary loan requests is permitted. Non-secure electronic transmission of files is not permitted. UCSD acknowledges that AAPG and other publishers of material in PUBS INTERNET own the respective copyrights for their data and agrees to abide by the other Terms and Conditions as posted on the access website and as otherwise as set forth in Paragraph 3 above.
