This is an Addendum to the JoVE and The University of California, San Diego License Agreement (the "Agreement") dated March 27, 2013 and made between the Licensor and the Licensee;

From the Date hereof the License Agreement shall be amended as follows:

Access is provided to all **journal** sections effective from March 25, 2019.

Trial access is included for JoVE Science Education - Clinical Skills until 6/30/2020 (temporary access only, not perpetual).

ACCESS METHOD

- Authentication via IP address
- 2. The License Agreement shall remain in full force and effect, and the terms of the License Agreement shall apply to the Licensed Material set out herein as if it were included in the License Agreement.
- 3. Licensee is permitted unlimited simultaneous use for the Licensed Materials.
- 4. The Agreement shall be automatically renewed at the end of the each current term (12 months) for an additional year unless either party gives written notice of its intention not to renew thirty (30) days before expiration of the current term. Licensee may renew at the same annual rate and terms for 2021 and 2022. Thereafter, Publisher will advise Licensee of the renewal terms at least 60 days prior to the end of each annual term.
