- 3. <u>Modification to Post Minimum Terms on Order Form</u>. The paragraph beginning with "Automatic Renewal Term for Window Products" is deleted in its entirety.
- 4. <u>Modification to Miscellaneous terms on Order Form.</u> The third sentence in the Section "Charges, Payments & Taxes" is deleted in its entirety.
- 5. <u>Modification to Miscellaneous terms on Order Form</u>. The Section "Banded Product Descriptions" is deleted in its entirely.
- 6. <u>Modification to Thomson Reuters General Terms and Conditions</u>. The complete section "Government on-Availability of Funds" is deleted in its entirety and replaced with the following:
